IN THE MATTER of an application by **Odyssey New Zealand Limited** for temporary authority (on) pursuant to s.136 of the Act in respect of premises situated at **403 Ngatarawa Road, Hastings** known as "**Salvare Estate**".

DECISION

This is an application by **Odyssey New Zealand Limited** for temporary authority (Off) in respect of premises situated at **403 Ngatarawa Road, Hastings** known as "Salvare Estate."

The premises operate as a grocery store and the sale of food items is the principal purpose of the business.

Reports were received from the Police and Licensing Inspector indicating no objection to the application.

No objection or notice of desire to be heard has been received.

The Committee has considered the application and approval is granted for a period of three months pursuant to Section 136(1) of the Sale and Supply of Alcohol Act 2012.

That the applicant be advised that it is the expectation of the District Licensing Committee that an application for a substantive licence is to be made within six weeks of the issue of the temporary authority.

The Temporary Authority is issued, commencement date **26 December 2016** subject to the following terms and conditions:

Pursuant to this temporary authority **Odyssey New Zealand Limited** is authorised to sell and supply alcohol, on the premises situated at **403 Ngatarawa Road, Hastings** known as "**Salvare Estate**."

The authority conferred by this licence shall be exercised through a manager or managers appointed by the licensee in accordance with subpart 7 of Part 2 of the Act.

CONDITIONS

That the temporary authority be issued with the following conditions:

- (a) **No liquor is to be sold or delivered on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day: EXCEPT THAT grape wine or fruit wine may be sold or delivered on Easter Sunday if the grape wine or fruit wine is made –**
- (i) on the premises; or**
 - (ii) from grapes or fruit harvested from land on which the premises are situated.**
- (b) **Liquor may be sold or delivered only on the following days and during the following hours:**

- (c) **The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.**
- (d) **Drinking water is to be freely available and free of charge to customers at the following location while the premises are open for business: At the counter when free alcohol samples are provided.**
